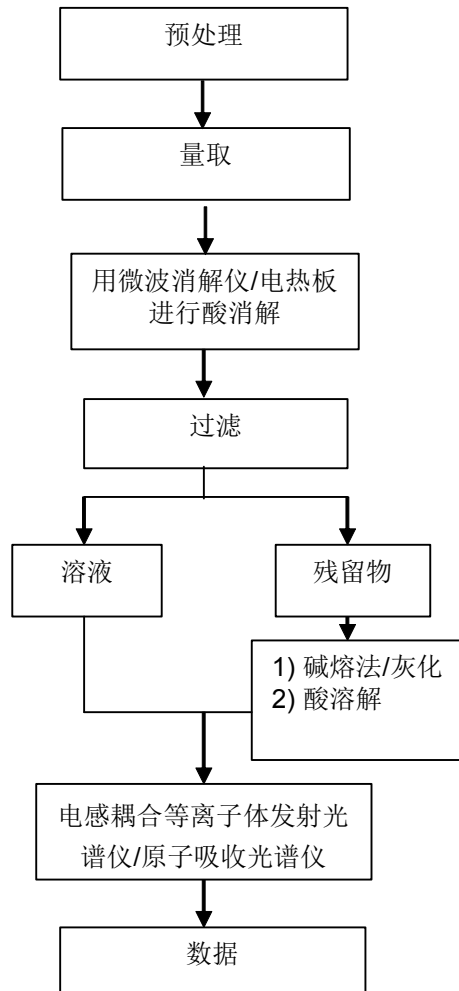

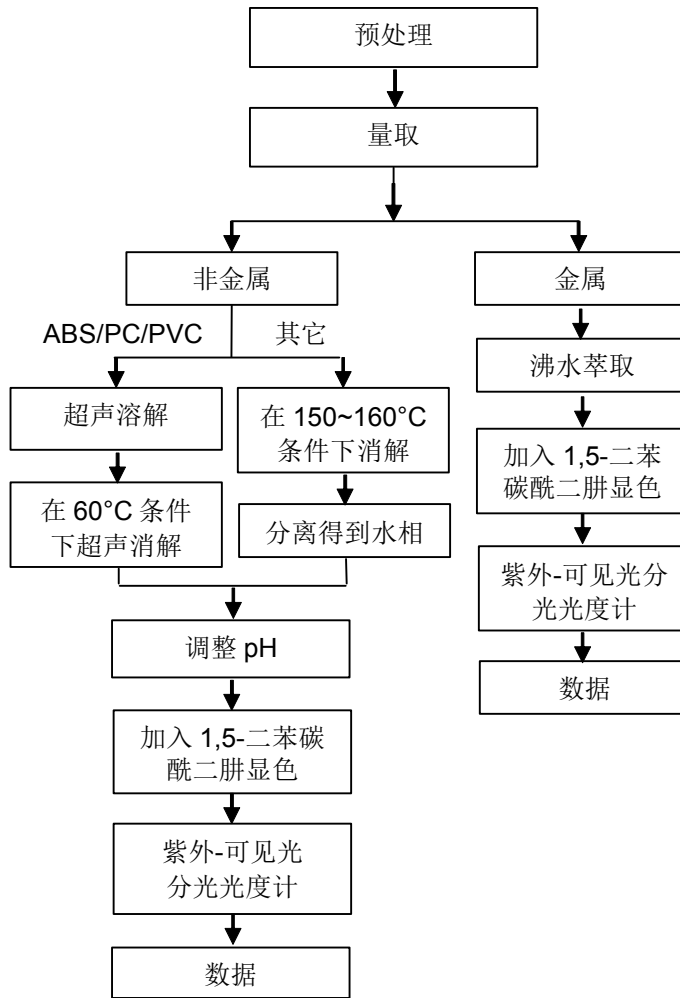
Pb /Cd / Hg 测试流程图

1)样品按照下述流程被完全消解

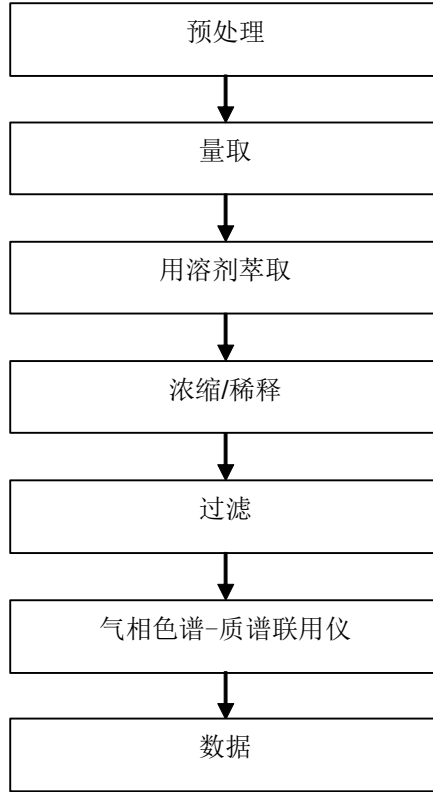

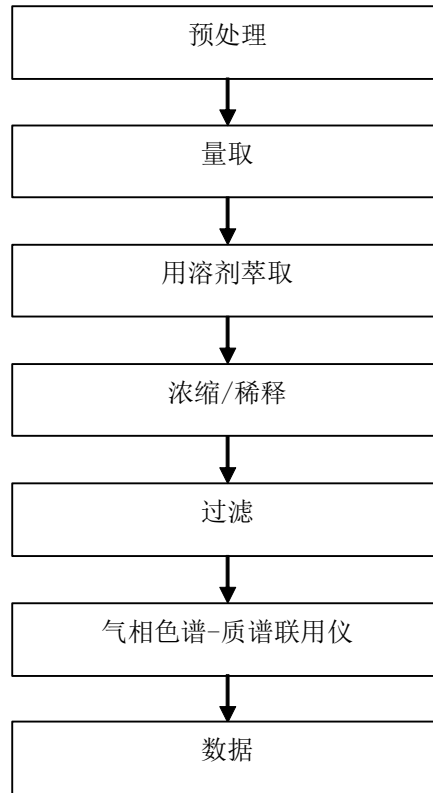
六价铬测试流程图



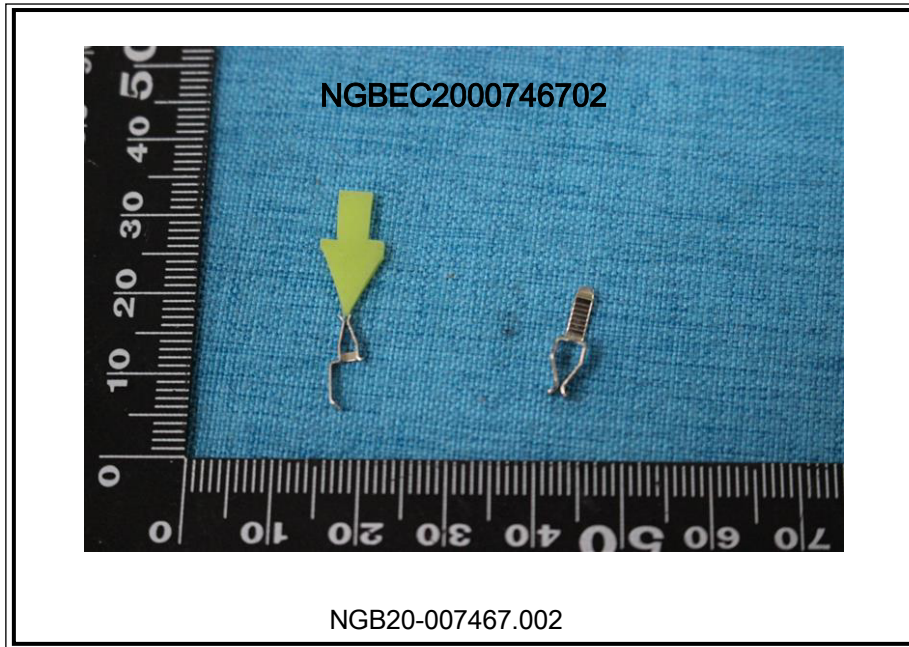
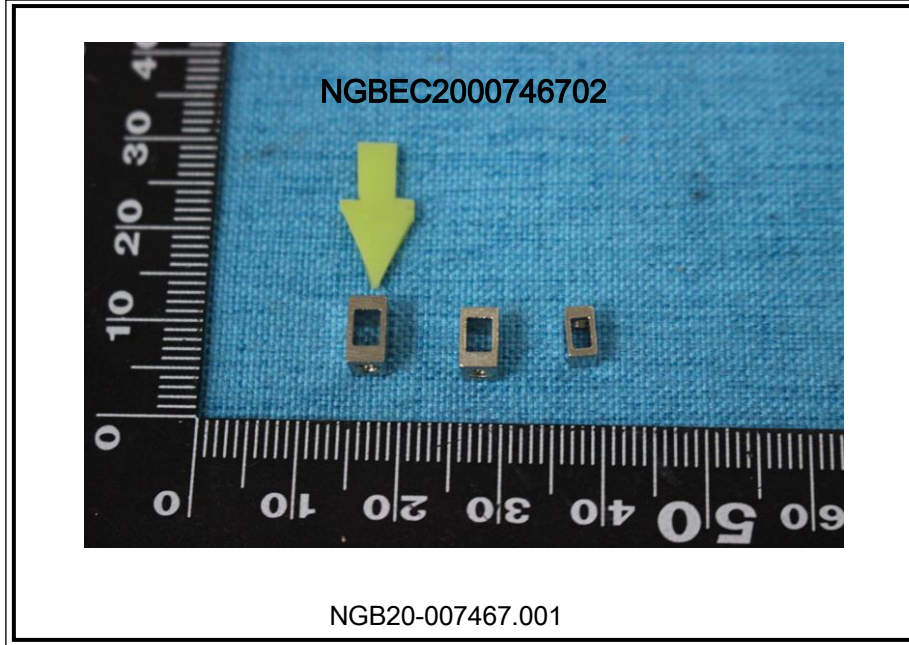
PBBs/PBDEs 测试流程图

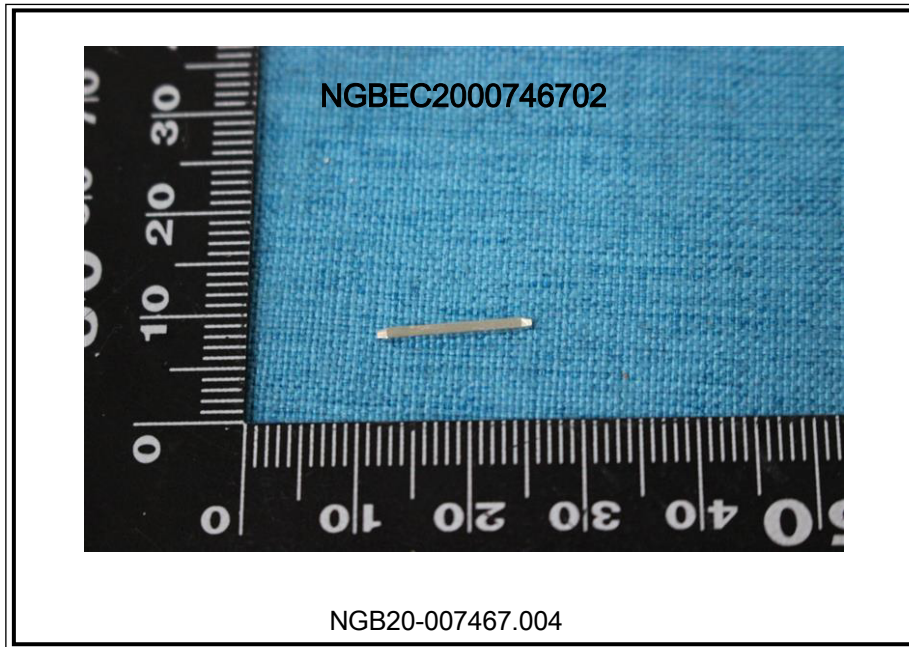
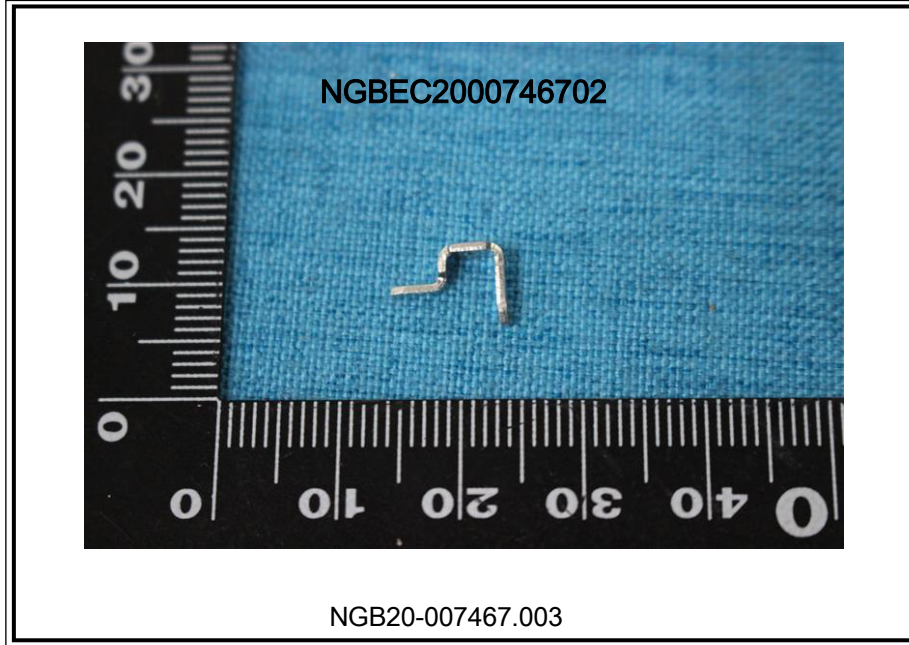


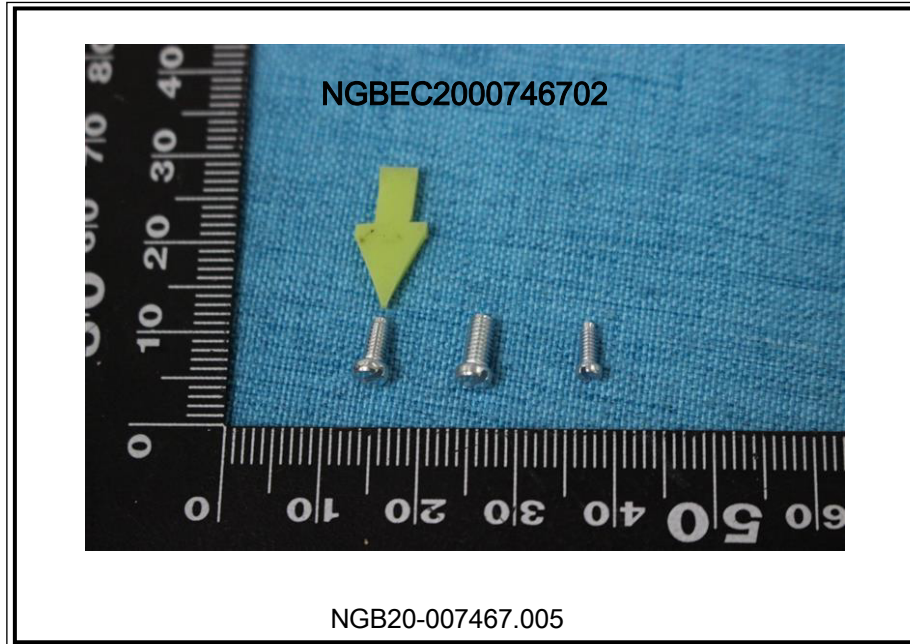
Phthalates 测试流程图
